1. Background

The Government of Sierra Leone has received financing from the African Development Bank Group toward the cost of the Digital Innovation for Government Efficiency and Sector Transformation (DIGEST) Project and intends to apply part of the agreed amount for this grant to payments under the contract for **Consultancy Services – Business Development and Investment Advisory Services (Individual Consultant)**.

The services included under this project/activity are:

- Develop and maintain a pipeline of digital enterprises, investment opportunities and strategic partnerships aligned with DIGEST priorities.
- Support the investment readiness of selected startups and SMEs, including business-model refinement, investor materials and access-to-finance pathways.
- Map and engage relevant investors, development partners, corporates, ecosystem actors and potential strategic partners.
- Advise on business-development and partnership approaches for Felel Tech City and the operationalisation of the Sierra Leone Innovation Investment Fund (SLIIF).
- Support the preparation of investment briefs, partnership concept notes, pitch materials and other business-development documentation.
- Facilitate targeted investor, partner and ecosystem engagements; document agreed actions and follow up on partnership opportunities.
- Provide periodic progress reports, including pipeline status, opportunities secured, constraints and recommendations for the Project.

The assignment is expected to be completed within eight (8) months from the date of contract commencement.

Interested consultants must provide information indicating that they are qualified to perform the services (brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills among staff, etc.).
